<p><b>Collection of Entertainment Pass</b></p>	<p>Each participant must collect their Entertainment Pass from Customer Service or Centre Management at Woodgrove Shopping Centre</p>
<p><b>Privacy</b></p>	<ol style="list-style-type: none"> <li>1. Under the Privacy Act 1998 (Cth), the Promoter must notify Participants of certain matters when it collects personal information about them including how it plans to use or disclose it. If a Participant chooses to enter or take part in the Promotion, the Participant may be required to provide the Promoter with personal information about themselves such as the Participant's full name and contact details.</li> <li>2. The Promoter will collect, use and disclose the personal information which the Participant has provided for the following purposes: <ol style="list-style-type: none"> <li>(a) carrying out the Promotion; and</li> <li>(b) carrying out marketing and competitions activities including, without limitation, sending newsletters or publications and/or other marketing and promotional material to the Participant about future competition or promotional events (which may be undertaken by the Promoter or any other person or organisation to which the Promoter discloses the personal information (including contractors) for the purposes of assisting the Promoter to do this; and</li> <li>(c) adding the Participant's details to the Centre's database;</li> <li>(d) supplying information to third party organisation which provide special prizes or offers;</li> <li>(e) adding the Participant's details to a database of a disclosed third party.</li> </ol> </li> </ol>
